VICTORIAN RACE BONUSES

a) **Tasmanian Sired Horses**

The new Tasmanian scheme does not pay bonuses for any horses that win or are placed in SuperVOBIS bonus races run in Victoria. In order to cater for those wishing to have access to these bonuses, a separate scheme (TasVOBIS) will operate in conjunction with the new scheme (tasBonus). The TasVOBIS scheme will be available to nominators of Tasmanian sired horses and will operate under the same fee, bonus and deadline structure as the Victorian scheme (VOBIS Gold not included). Nominator fees to the new tasBonus scheme may be waived if the more expensive TasVOBIS option is chosen. See examples below.

Examples:

1. A breeder wishes to make their Savoie Vivre yearling more attractive to buyers at the Yearling sale/s. He/she nominates the yearling into the TasVOBIS scheme at a cost of \$660. The yearling will be automatically “breeder nominated” into the new Tasmanian scheme, as well, without paying the additional \$220 breeder nominator fee. The existing TasVOBIS logo will appear in the sales catalogue, in addition to the new scheme logo.
2. The buyer of a West Quest yearling, which has **NOT** been TasVOBIS nominated prior to the sale wishes to make the horse eligible for Victorian race bonuses. He/she must pay the late entry fee of \$1,320 to join the TasVOBIS scheme, however in doing so will not be required to pay the \$330 “owner nomination” to be eligible for Tasmanian race bonuses.
3. A breeder intends to race his Incumbent yearling and wants to make the horse eligible to win bonuses in both Tasmania and Victoria. He/she must pay \$660 to join TasVOBIS and will automatically be “breeder nominated” into the new Tasmanian scheme. To to be eligible to win Tasmanian “owner bonuses” an additional \$330 must be paid by June 30.

b) **Victorian Sired Horses**

Only Tasmanian sired horses will be eligible to join the TasVOBIS scheme. Victorian sired horses need to be nominated and paid for through Racing Victoria to be eligible for SuperVOBIS bonuses on Victorian races. There will be no compensation or waived fees for SuperVOBIS horses entering the Tasmanian scheme.
