

Greyhound Policies | Bonuses – Owners & Breeders

GPOL0014

1. OBJECTIVE

1.1 To document the conditions and amounts of bonuses payable to owners and breeders of greyhounds by Tasracing.

2. **DEFINITION**

"Tasbred" means a Tasmanian Bred greyhound as defined in the Grading Schedule as a greyhound whelped in Tasmania.

3. POLICY

3.1. TASBRED BONUS

A bonus of \$100 will be paid for all races won by Tasbred providing:

- 3.1.1. Stakemoney for the winner is less than \$2,000 and
- 3.1.2. The race is not restricted to Tasbred greyhounds

3.2. TASBRED JUVENILE BONUS

A bonus of \$300 will be paid to any Tasbred greyhound on winning a Juvenile grade at all three (3) tracks in Tasmania.

3.3. BREEDER'S BONUS

A bonus of \$1,300 will be paid to the Breeder on registration by Racing Services Tasmania of any litter which is whelped in Tasmania. At the close of each month RST shall provide a list of litters registered during that month to Tasracing.

3.4. DNA TESTING OF BROODBITCHES

The laboratory fee for the DNA testing of broodbitches will be reimbursed to the owner if:

- 3.4.1. The DNA testing is carried out to meet the requirements of GAR
 138(1) and not the result of any inquiry or investigation or parentage verification; and
- 3.4.2. The broodbitch whelps in Tasmania.
