
GPOL0032

1. OBJECTIVE

- 1.1 The objective of this policy is to document the procedure (except in extraordinary circumstances determined by Tasracing) for the programming of races of specific grades and or distances when formulating the Forthcoming Programmes.

2. POLICY

- 2.1 Hobart, Launceston and Devonport shall programme, where possible, a Maiden race once a month on consecutive weeks avoiding any Qualifying Finals.
- 2.2 The following shall apply to 278/340 metre races:
- 2.2.1 340 metre races will be programmed bi-monthly at Hobart at approximately fortnightly intervals and shall be programmed for Juvenile/Maiden, Graduation/Trial and Free-to-All grades on a rotation basis.
 - 2.2.2 A 278 metre race will be programmed at every meeting at Launceston and shall be programmed for Juveniles, Grade 5, Grade 4 and Invitation grades on a rotation basis.
 - 2.2.3 The frequency of the programming of 278/340 metre races and the rotation of grades shall always be subject to other races scheduled at the time the programmes are approved.
- 2.3 A middle distance race will be programmed at each meeting by each Club on a rotating grade basis of Maiden/Juvenile, Juvenile/Graduation, Graduation/Trial and Free-to-All.
- 2.4 Qualifying Trials shall be scheduled at Hobart approximately every six weeks and at Devonport approximately every eight weeks. Qualifying Trials will not be scheduled at Launceston
