### IMPORTANT INDUSTRY NOTICE

#### **RATINGS HANDICAPPING UPDATE**

As we enter our fifth month under the new Ratings Based Handicapping System it is important to gather feedback from the industry as we prepare for the six-month review.

Each state will meet early in 2020 to discuss the performance of the Handicapping system including any possible modifications going forward.

Common areas so far identified by local industry participants include:

- 1) 3YO's and inexperienced horses opportunities and earning potential reduced?
- 2) 2YO points transition
- 3) Concession driver tier number of wins too high for Tasmania
- 4) Being able to drop back too far

These amongst other items have been discussed during regular teleconferences with all states.

It seems stakeholders from most states also feel strongly about 3YO's and how they fare under the Ratings system.

If modifications to the system are supported strongly enough by the majority of the industry there may be a chance for change after the sixmonth review.

If you feel strongly enough that change or some tinkering to the system is necessary, you should speak up now and offer possible solutions to consider going forward.

In general terms racing under the Ratings Based Handicapping System has demonstrated a significant reduction in short priced favourites \$1.60 or less and more competitive racing with shorter margins between first and last. Wagering service providers and administrators across the country have provided very encouraging feedback and full support for the Ratings system based on the results they are experiencing, some even describing as "the most positive reform in the sports history".

## ... Ready for State duties in New Zealand

Two-time leading Tasmanian junior driver Conor Crook has been chosen to represent his adopted home state at the 2019 Hanley Formula Australasian Young Drivers Championship in New Zealand.

The eight-race series commences at the Addington Raceway in Christchurch before the action moves on to the grass track at Methven. Competitors then ventures to the north island for heats at Manawatu before the final heat on Inter Dominion eve at Auckland's Alexandra Park on 12 December.

Crook stated, "I'm really looking forward to it, I went to the New Zealand Cup and had a ball so to go back and drive and represent my new home state is an honour," said the 23-year-old.

Like most young people in the industry, Crook became involved through family involvement. "My father (Peter) and brother (Luke Hooper) have always had a couple of horses in work back home and my brother was getting most of the drives so I thought I would go out on a limb and come down here to Tasmania halfway through 2017," said Crook.

Crook had only a handful of drives when based at Cowra in central New South Wales where he had spent time helping his family's small team of horses around full-time employment with the local Coles supermarket, before taking on a position with the state's leading trainer Ben Yole.

"I had been looking for a junior driver job for a while at the time and the Yole's advertised a job down here in Tas and I was able to get it," Crook explained. "The plan was to come down here for a month and see how I enjoyed it," he laughed. Crook still picks up several drives for the Yole stable, but he has since taken up a position with well-respected trainer-driver Rohan Hillier, and the duo has built up a great combination, in particular with talented gelding Awayandrideyourself who Crook has driven to seven of his eight wins since the pacer arrived in the state.

"He is one of my favourites to drive as he gives you 110%, plus he helped me win the junior driver premiership last season when we won the Jubilee Bakery Stakes at the last meeting of the season," explained the talented young driver.

There is no doubt that many in the industry would agree when Crook arrived in the state he had a lot to learn in the sulky, and he has certainly improved out of sight, with many trainers and owners using his services, sometimes without his five-point concession claim.

"Mark (Yole) was a very big help early on but there were many senior drivers that stopped and gave advice," said Crook who is currently equal fourth on this season's overall drivers title.

"Rohan and Troy (Hillier) have been terrific in recent times and they are terrific people to learn off, plus Troy brings good coffee and pies from his bakery when he arrives at the stables," laughed the winning driver of 65 races.

Crook will be out to continue the success of many Tasmanians that have won the series including Gareth Rattray who won the series in 2003 that was held in New Zealand before winning the series later on in 2010, James Austin (2007), Adrian Duggan (1997) and Ricky Duggan (Dead Heat in 1993). Before 1993 the series was for Australian drivers only where there was also success with; Rohan Hadley (1990), Leigh Dornauf (1980) and Don McVilly (1978).

There is a bonus to winning this year's 2019 Hanley Formula Australasian Young Drivers Championship with the winning driver to be invited to drive in the famed Swedish Guldklockan (Gold Watch) series, held at Sovalla, Stockholm in December next year.

### AUSTRALIAN DRIVERS CHAMPIONSHIP claimed by Gary Hall Inr for WA

Gary Hall Jnr claimed Western Australia's first Triple M Australian Drivers Championship win in Hobart. Hall Jnr was able to record a driving double and two placings across the seven-race series to score a 14-point victory over Tasmania's Mark Yole with Darby Mcguigan a further three points away in third. Here is how the night unfolded.



#### HEAT 1

Western Australia's Ryan Warwick was able to pick up maximum points in the first heat when he scored on the Todd Rattray trained Wandary Muscat, from inside of the second row Warwick ended up four-back along the marker pegs before weaving his way through the field to use the sprint lane over the concluding stages to record a 1.5-metre win. "It just worked out well, obviously the moving line slowing down the back (straight) was a good thing and was able to get a good trip," said Warwick postrace on Tasracing's Live Stream.

#### HEAT 2

Darby McGuigan was able to do the right thing by favourite punters aboard Cool Water Paddy who started the shortestpriced favourite of the night at \$1.65. The Juanita McKenzie trained pacer worked forward early to find the lead at the 1500mark and was too good late to record his fifth win in a row by 5.2-metres over the second elect Sheza Bettormak with Thomas Burns a clear third. "He seems like a nice horse and from his replays I watched he looks a nice horse, he was a beautiful horse to drive, he just settled so easy and when I asked him to go he went which is the sign of a good horse," McGuigan said.

"He seems like a versatile horse and he reeled off some good sectionals there and I think he will be able to mix it with the metropolitan horses at Melton," added the winning driver.

#### HEAT 3

This was an action-packed heat with short price favourite Awayandrideyouself looming up looking a chance in the home straight but unfortunately for favourite punters and Queensland's Pete McMullen

the sulky seat became detached causing McMullen to be dislodged from the sulky, McMullen was cleared by the Medical Edge Staff for his remaining drives, and no harm was caused to Awayandrideyourself who was quickly caught by the clerk of the course Zane Medhurst. The heat was won by Tasmania's Mark Yole aboard the Paul Hill trained gelding Streitkid, pushing through from the second row Streitkid was able to sit one-out and two-back before peeling three-wide with 350-meters to travel and was too good in the straight to defeat Hafter by 3.4-metres with Rowley back in third spot. "He has done a good job this horse, the quick tempo and a nice sit certainly told up the straight ... I have got to give credit to trainer Paul Hill, he said to follow through on the back of Rowley and see if you can get some cover and as it turned out it gave us a beautiful sit and things worked out from there," explained Mark Yole.

#### HEAT 4

Was the first win for Gary Hall Jnr when he drove the Chris Howlett trained Iden Forest to a half neck victory. Regular Tasmanian harness racing followers will know that Iden Forest has the ability but his manners early and his poor manners has let him down on several occasions in the past. Hall Jnr pushed forward to race outside the leader and after being headed by Hear The Call in the home straight, Iden Forest was able to rally back for his second win of the season over Hear The Call and Betterthanfetta, "We did a lot more than I wanted early but he could have had it easy on himself to get to the front but I had trouble getting the best out of him, to his credit he kept rolling the same speed all the way ... he has done a really good job to hold the swoopers late, its a good thing he has a bit of size about him," said Hall Jnr after the win.

#### HEAT 5

Koolaz Elvis was an unlucky second in Launceston last week yet slipped under the guard of punters starting as an \$11 chance in a competitive rating 70 to 84 event. Gary Hall Jnr, driver of Koolaz Elvis worked forward to find the lead and allowed the gelded son of Courage Under Fire to stride along in front in guarters of 29.5s, 30.1s, 28.7s and 28.4s for the quickest mile rate of the night of 1m 57.3s. "The boys said I could take a sit if I wanted and were happy to leave it up to me if the right one came around, and he (Yatsenyuk Leis) probably was the right one but he wanted to take charge a little bit and I was happy to let him do what he wanted in front and to his credit he boxed on real well late," said Hall Jnr after his second win of the series.

#### HEAT 6

The Ray Pullen stable has been going well in recent weeks and that continued with sixyear-old mare Gipsy Treasure who recorded back-to-back wins in heat six. Driver Todd McCarthy took the race favourite straight to the early lead and gave nothing else a chance to defeat El Jays Blu by 1.9-metres with Blue Eyed Creation some 11.8-metres away third. "She was terrific, we had to do a little bit to get around and then we were lucky enough to get a few cheap quarters and she fought them off well in the finish," said McCarthy after the event.

#### HEAT 7

South Australian Ken Rogers was able to test success in the final heat of the championship aboard the Heath Woods trained pacer The Shallows. Rogers got straight off the inside to sit one-out and three-back before leading up the three wide line from the 1000-metre mark, before putting the foot to the floor at the 600-metre mark to record a 4.7-metre win over Vouvray Beach with Our Percius back in third spot. The win completed a hattrick of wins for the lightly raced gelded son of Shadyshark Hanover who looks to have a bright future ahead.

#### **MEET THE DRIVERS:**

Hannah Vandongen – finished in tenth position on the states drivers premiership last season with 24 wins and 38 placings and the Carrick based driver has already started the 2019-2020 season well recording six wins and nine placings.

**Taylor Ford** – will be out to follow in the footsteps of her father Phillip who is a past winner of the series. Ford registered 18 wins last season with a further 25 placings to her credit to finish in third position on the states female drivers title.

Lachlan Dakin – had his first race drive in March 2018 before driving his first winner in August that year aboard Goggo Gee Gee. Dakin, who works for trainer Todd Rattray has shown continued improvement in the sulky which seen him drive six winners last season, with a further two wins added to his tally this season.

**Ben Woodsford** – hails from New Zealand and had been gathering experience in Australia from several leading stables before finding his way to Tasmania earlier this year. Woodsford had his first race drive at Menangle in May 2016 aboard Big Bang Penny who gave him his first winner at Newcastle in August 2016. He has driven a total of 37-wins through his career including two victories this season on Rocket Blaster.

**Charlie Castles** – is continuing a strong family tradition into the industry and is the sole northwest coast based competitor in this year's series. Castles drove four winners last season but found himself amongst the placegetters on 25 occasions.

**Georgia Hayward** – is still chasing her first winner in the sulky but she has shown in recent drives that her first win isn't too far away. **Andrew Freeman** – is a relative newcomer to the sport only having his first race drive this year aboard Mighty Spark in Burnie. His first winning drive was on the Ben Yole trained Hez The One in Hobart in April.

**Matthew Howlett** – is the most experienced driver in the series with 68-wins and 169 placings to his credit since his first race drive in November 2012. Howlett set a Youngbloods Challenge record when he became the youngest driver to win the series at 16 years and seven months winning the series in 2013 while also claiming the title in 2016.

**Samantha Freeman** – recorded her first win in July 2013 and has found the winners stall first on a further 27 occasions. She dead-heated for first in the BOTRA Claiming Novice Drivers series in 2014.

**Justin Howlett** – drove his first winner at his very first race drive on Rock And Run in Hobart in June 2008. A talented concession driver in his time Howlett has elected to take a back seat and allows his brothers Matthew and Braden do most of the driving for their father Chris.

**Wade Rattray** (First Emergency) – started his driving career in June 2014 and registered his first win a month later in Hobart on Divas Delight for his uncle Barrie. Rattray won the series in 2015.

#### FEATURE RACE CONDITIONS

#### TASSIE GOLDEN APPLE RACE CONDITIONS - Saturday 21 December 2019

A standing start event to be conducted in two heats and a final at Launceston over 2200 metres. The series will be a conditioned handicap with a Random Barrier Draw as follows:

NR 80-86 – Front

NR 87-93 – 10 metres

NR 94-104 - 20 Metres

NR 105 or more - 30 metres

No mare or driver concessions apply to this series.

A field limit of 12 horses applies to both the heats and the final.

In the event of more than 24 nominations for the heats, the selection of the fields will be done on the highest National Rating to the lowest National Rating. In the case of horses with equal National Ratings the horses will be selected on Field Selection Points from highest to lowest and if still equal a random ballot between those horses shall then be conducted.

The allocation of horses to each heat shall be manual allocation based on the National Rating of each horse selected to participate as follows:

The horse with the highest National Rating shall be allocated to heat 1, the horse with the second highest National Rating shall be allocated to heat 2, the horse with the third highest National Rating will be allocated to heat 1, the horse with the fourth highest National Rating shall be allocated to heat 2 etc In the case of horses with equal National Ratings the horses will be allocated on Field Selection Points from highest to lowest and if still equal a random ballot between those horses shall then be conducted.

The first six horses finishing in each heat shall be deem qualified for the Final with the seventh placed horse in the fastest heat being named as the emergency. Horses qualifying for the Final shall start from the same handicap as in the heat.

#### FEATURE EVENTS CALENDAR AMENDED

During the process of reviewing and finalising the forthcoming programs, the following amendments to the Feature Events Calendar have been approved:





When races are divided by points (high and lower points divisions), the Unfulfilled Engagements and Extended Races policies do not apply if the total number of acceptors is equal to, or less than, the combined field limits.

#### Claimers in Open Class Races

In order to provide claimers with a continuity of opportunities to race, they will be permitted to race where "Also Eligible" conditions stipulate.

Claimer eligibility will be determined by aligning the claiming price with the following ratings points:

Concessions will operate as per the Mares Concession and Novice Driver Concessions as approved from time to time.

Claimers nominating for races under the "Also Eligible" clause shall be deemed eligible for the race if they meet the also eligible criteria and shall not be deemed to be nominating in advance of their rating. Claimers with a transition rating less than the front of the race shall be deemed to be a rating of the front of the race.

If ballots are necessary, those horses eligible for the race by way of their claiming price shall be first eliminated.

In races where the draw is (or is in part) a PBD/NR, horses eligible by way of their claiming price shall be drawn at the end of each rating. For example, horses with a claiming price up to \$5000 will be eligible for a 65 to 70 rating race if the conditions permit and horses with a claiming price up to \$4000 will be drawn after the 65 rating horses, but before the 66 rating horses and the horses with a claiming price of \$5000 will be drawn after the 70 rating horses.

**190AB.** (1) A horse must not at any time be administered an unregistered bisphosphonate. (2) Any person who:-

- (a) Administers an unregistered bisphosphonate
- (b) Attempts to administer an unregistered bisphosphonate
- (c) Causes an unregistered bisphosphonate to be administered and/or
- (d) Is a party to the administration of or an attempt to administer any unregistered bisphosphonate to a horse is guilty of an offence.
- (3) Where the Stewards are satisfied that a horse has, or is likely to have been, administered an unregistered bisphosphonate contrary to this rule, the Stewards may prevent the horse from starting in any relevant race.
- (4) When a sample taken from a horse aged less than four years has detected in it a bisphosphonate the horse is not permitted to start in any race for a minimum period of twelve months from the date of the collection of the sample in which the bisphosphonate was detected.
- (5) When a sample taken from a horse aged four years or older has detected in it
  - (a) A registered bisphosphonate the horse is not permitted to start in any race for a minimum period of thirty days from the date of the collection of the sample in which the bisphosphonate was detected.

- (b) An unregistered bisphosphonate the horse is not permitted to start in any race for a minimum period of twelve months from the date of the collection of the sample in which the bisphosphonate was detected.
- (6) When a sample taken from a horse has detected in it a bisphosphonate in breach of sub-rules (1), (4) or (5) the trainer and any other person who is in charge of such horse at the relevant time shall be guilty of an offence

#### 14. GENERAL OFFENCES Blood Doping

254A. (1) Subject to sub-rule (2) a person shall not either directly or indirectly withdraw from a horse, manipulate and reinfuse into a horse homologous, heterologous or autologous blood products or blood cells.

- (2) A registered veterinary surgeon may for lifesaving purposes or through use of veterinary regenerative therapies for the treatment of musculoskeletal injury withdraw from a horse, manipulate and reinfuse into a horse homologous, heterologous or autologous blood products or blood cells.

#### AUSTRALIAN HARNESS RACING RULES RULES AMENDMENTS

#### DICTIONARY

#### Amend definition of "Driver"

"**Driver**" means a person who is on a racecourse, racetrack or a registered or unregistered training track for the purpose of driving or riding a horse.

#### Add definitions:

"Artificial breeding" means artificial breeding as defined by Australian Harness Racing Rule 281.

"Australian Trotting Stud Book" or "Stud Book" means the annual Stud Book comprising a record of all Standardbreds active in breeding and racing and all horses named subsequent to the publication of the previous Stud Book together with such information and records deemed necessary by the Keeper of the Stud Book.

#### "Breeder" means:

- (a) In the case of a foal which is the result of an embryo transfer, the registered owner orlessee of the donor mare at the time the embryo is flushed from such donor mare andimpregnated into a recipient mare.
- (b In all other cases, the registered owner or lessee of the dam at the time of last date of service.

"Foal Died" is a foal that is still born, dies during birth or does not stand and suckle after birth.

"Foreign horse" means a horse foaled outside Australia.

**"Keeper of the Stud Book"** is the person appointed by Harness Racing Australia to keep records of sires, mares and foalings and to publish annual editions of the Australian Trotting Stud Book in accordance with the Australian Harness Racing Rules.

"Live Foal" is a foal that stands and suckles after birth.

"**Registrar**" is the person appointed by Harness Racing Australia to supervise the allocation of names of sires, dams and progeny.



HARNESS RACING AUSTRALIA

"**Sample**" means a sample or specimen of saliva, urine, perspiration, breath, blood, tissue, skin, hair or any other excretion, bodily fluid, tissue or matter taken from a person".

Approved by Tasracing 18th November 2019 - Effective immediately

#### 1. CLUBS

Qualifying / requalifying supervisors

• Amend Rule 6(1)

6.(1) Clubs, persons or bodies and such other persons as the Controlling Body may determine, may make application to the Controlling Body for the appointment of persons as qualifying/requalifying supervisors.

#### 2. STEWARDS

Appointment

Amend Rule 14(2)

14.(2) One steward shall be appointed Chairman of Stewards and others may be appointed Deputy Chairman of Stewards.

#### 3. MEETING AND RACES Security of horses

• Amend Rule 26(1) (4), (5)

- 26.(1) The Controlling Body shall in respect of any race determine all applicable security arrangements including those applying to a horse or horses.
  - (4) From the time of notification until the start of the race the connections shall ensure that the horse is located in accordance with sub-rule (2) and that it is available for inspection and testing by the Stewards.
  - (5) A horse tested under sub rule (4) which is found to have in or on its body a substance specified in Rule 190A(2) or is considered by the Stewards to be otherwise unfit to race shall be withdrawn from the race.

#### Disqualification

- Amend Rule 65
- 65. If the Stewards find that a horse or a trainer or driver was ineligible to compete in a race they may disqualify the horse from the race or declare such horse a non-starter and make any consequent changes to the placings.

#### 5. HORSES

Eligibility for registration and naming

- Amend heading
- Amend Rule 93(1), (3)
- Add new Rule 93(5), (6), (7), (8), (9)
- 93.(1) A horse shall not be eligible for registration unless:
  - (a) It is the progeny of a registered Standardbred sire and a registered Standardbred mare and its registration conforms with these rules.
  - (b) It is microchipped in accordance with HRA's Microchipping Regulations, freezebranded or otherwise identified by a method approved by HRA.
  - (c) It has been parentage verified by D.N.A. genotyping at a laboratory approved by HRA.
  - (d) It is progeny that conforms to the following genetic principles:
    - (i) Chestnut colouration is recessive to all other colours and therefore any progeny that is not chestnut from a chestnut to chestnut mating is not eligible for registration;
    - (ii) Grey colouration is usually dominant in relation to all the basic colours and therefore any progeny that is grey is not eligible for registration unless at least one of its parents is also grey.

Notwithstanding sub-clauses (i) and (ii) such progeny will be eligible for registration in the event that blood typing and / or D.N.A. genotyping establishes to the satisfaction of HRA that the horse in dispute is the progeny of the said sire and dam.

- (2) Save and except for embryo transfer or some other procedure approved by the Controlling Body a horse shall not be eligible for naming and/or registration and entry in the Stud Book if it is the produce of genetic engineering procedures including but not limited to cloning, embryo freezing or oocyte collection.
- (3) The progeny of a mare inseminated by transported semen shall not be eligible for naming and/or registration and entry in the Stud Book unless all steps taken to bring that progeny into being have been in accordance with these rules.
- (4) The Controlling Body shall not register a horse foaled outside its jurisdiction unless the horse is eligible for registration in an Australian State or Territory or its place of foaling.
- (5) A person seeking registration shall pay to the Controlling Body such fees relating to identification as it may determine.
- (6) The connections shall keep clipped that area of a horse's body adjacent to or surrounding its brand.
- (7) In the event of the identification of a horse becoming indistinct, illegible or otherwise unsatisfactory to the Controlling Body, the connections shall comply with any directions given by the Controlling Body to rectify the matter.
- (8) A person who fails to comply with sub-rule(6) or a direction given under sub-rule (7) is guilty of an offence.
- (9) Where a person is guilty of an offence under this rule, the Controlling Body may take such action with regard to the horse as it may determine.

#### • Amend Rule 94(1), (2), (3), (4), (5), (6)

- 94.(1) A horse shall not be eligible for naming unless:
  - (a) the horse has been registered in accordance with Rule 93.
  - (b) the name is submitted through the Controlling Body.

- (2) A Controlling Body shall not permit any horse to participate in any breeding or racing activities in its jurisdiction unless and until it has a name approved by the Registrar.
- (3) Each State Controlling Body shall have incorporated on its standard name application form an acknowledgement and acceptance by the owner of the horse of complete legal liability should a name be submitted and name be allocated which infringes any trademark or copyright.
- (4) A Controlling Body may delete a name or names before the list of names is submitted to the Registrar.
- (5) (a) The Registrar shall allocate the first available name on the list of names submitted by a Controlling Body after having first eliminated the following:
  - (i) Any existing names of trotting or pacing horses appearing on the Australian name register or the name of any past renowned racetrack performer as identified in the Protected Name Lists

     Renowned Winners and Oaks / Derby Winners or as a winner of a race specified in the Harness Racing Australia Racing Chronicles.
  - (ii) Any name having political, religious, sacred or commercial significance or that is otherwise inappropriate.
  - (iii) Any name of indecent, undignified or irreverent character in English or any other language.
  - (iv) Any name having single initials or numerals, either as a whole name or used as a part of a name with the exception of the letter "A" or "I" (overseas horses excepted).
  - (v) Any name likely to cause confusion by reason that it sounds or reads the same as an existing name.
  - (vi) Any name of a well known living or dead person the naming of which would be objectionable to the persons concerned, to relatives or

to others in general. Names of wellknown persons, living or dead are acceptable if written permission has been obtained from either the person (if they are living) or from the family (if they are deceased). The naming applicant is responsible for obtaining written permission.

- (vii) Any name of an Australian Institution or Organisation, or any name which does or may infringe trademark or copyright. (Including songs, movies, books & TV shows).
- (viii) Any name the reverse of which is the name of a horse currently racing.
- (ix) Any name likely to cause confusion in breeding records by reason that it is the duplicate of a name prominent in breeding or racing outside Australia.
- (x) The name of any Sire or Dam in the Australian Trotting Stud Book.
- (xi) Any name more than eighteen letters in length (including spaces).
- (xiil) Any name in any other language than English where the meaning cannot be proven.
- (xiii) Any name that is difficult to pronounce in English or any other language.
- (b) The following are not permitted to be used in a name:-
  - (i) Apostrophes, full stops, dashes, characters, numbers and symbols – eg, hyphens (-), acutes (é), circumflexes (ê), cedilla (ç), graves (è), umlauts (ä), etc.
  - (ii) Abbreviations such as Mr, Mrs, Ms, Dr . The words must be spelt out in full.
- (c) The Registrar may correct any misspelt or incorrect renderings of a word or phrase.
- (d) Names submitted using part or all of the Sire and / or Dam name should be spelt the same as the Sire and / or Dam name.
- (e) If all names on a list are eliminated the Registrar shall call for a new list to be submitted.

- (6)(a) Subject to paragraphs (b), (c) and (d), a name once allocated by the Registrar shall not be changed.
  - (b) The owner of a yearling that has been allocated a name by the Registrar shall upon payment of the prescribed fee(s) be permitted to change the name provided the horse has not competed in an official trial, race or bred and the change is made before the end if its yearling season. Any cancelled name will be made available for re-use after 12 months.
  - (c) The owner of a horse 2 years old or older that has been allocated a name by the Registrar shall upon payment of the prescribed fee(s) be permitted to change the name provided the horse has not competed in an official trial or race or has not bred. Any cancelled name will be made available for re-use after 12 months.
  - (d) The owner of a horse 2YO or older that has been allocated a name by the Registrar and has competed in an official trial in any country can apply to change the horse's name by submitting an application in writing to the Registrar outlining reasons for wanting the change. The application will be considered by the Keeper of the Stud Book and the Registrar, and if approved, will require payment of the prescribed fee(s). Any cancelled name will be made available for re-use after 12 months.

#### Naming and registration

- (4) A person making application to name a horse shall ensure that all proposed names comply with Rules 93 and 94.
- (5) Application to name or register a horse shall be made on form R95-A.

- (7) The Controlling Body may cancel the registration of a horse.
- (8) A person who fails to comply with sub-rule (4) is guilty of an offence.

#### Naming and registration - Foreign horses

Add new heading

#### Add new Rule 95A

95A (1) A foreign horse shall be eligible for registration in Australia provided such horse:

- (a) Is registered with the controlling trotting authority of the country it was cleared from; and
- (b) Is a Standardbred; and
- (c) Has been parentage verified by D.N.A. genotyping or blood typing.
- (2) Aforeign horse shall not be eligible for registration in Australia until such time as:
  - (a) HRA receives a clearance certificate from the country in which such foreign horse was last registered, and
  - (b) The appropriate clearance registration fee is paid, and
  - (c) It is microchipped in accordance with HRA's Microchipping Regulations, freezebranded or otherwise identified by a method approved by HRA.
- (3) Upon the receipt of a Clearance Certificate a foreign bred horse shall be allocated its existing name and in addition shall have a suffix added to its name to denote the country of origin.
- (4) The suffix to be added to the name shall be as follows:

- (5) The name of a foreign horse will be checked by the Registrar for verification and recording and the Registrar shall advise the Controlling Body that the name is available or otherwise.
- (6) If the name is not available then a prefix will be applied, and under certain circumstances a new name may be requested by the Registrar. In such case where a name is changed the suffix applicable shall be added to the new name.
- (7) If the name of a foreign horse is of a well known living or deceased Australian person, permission

must be obtained by HRA from either the person (if they are living) or from the family (if they are deceased) to allow the name in Australia. Otherwise a name change may be requested by the Registrar.

- (8) The owner of a yearling bred outside Australia shall upon payment of the prescribed fee(s) be permitted to change the name provided the horse has not competed in an official trial or race either in Australia or Overseas, has not bred and the change is made before the end of its yearling season in Australia.
- (9) The owner of a horse 2 years old or older bred outside Australia shall upon payment of the prescribed fee(s) be permitted to change the name provided that horse has not competed in an official trial or race either in Australia or overseas, or has not bred.
- (10)The owner of a horse 2YO or older bred outside Australia that has been allocated a name and has competed in an official trial in any country can apply to change the name by submitting an application in writing to the Registrar outlining reasons for wanting to make the change. The application will be considered by the Keeper of the Stud Book and the Registrar, and if approved, will require payment of the prescribed fee(s). Any cancelled name will be made available for re-use after 12 months.
- (11) Apostrophes, dashes and dots which are part of a foreign horse name will be eliminated.

#### Add new Rule 95AB

- 95AB (1) If any matter that is not specifically covered by these rules arises the Registrar may allow a name or a new name.
- (2) The Registrar may order a change of name wherever such change is deemed necessary to comply with the context of these rules.

Registration certificate - deregistration of a horse

- Renumber existing 96A(3) to 96A(3)(a)
- New Rule 96A(3)(b)
- Amend Rule 96A(4)(a)

96A.(3) (a) Where a registered horse has been retired from racing or a decision has been made to not race the horse, the owner or trainer of the horse at the time of its retirement must, within one month of the horse's retirement, notify the Registrar by lodging the relevant form prescribed by the Registrar.

- (b) Where a registered horse has been retired from racing or a decision has been made to not race the horse but retain it for the purposes of breeding, the owner of the horse at the time of its retirement from breeding must, within one month of the horse's retirement notify the Registrar by lodging the relevant prescribed form.
- (4) The owner, or trainer of the horse at the time of its death shall:-
  - (a) In the case of a horse which dies within fourteen (14) days of being entered for or participating in a race notify the Controlling Body of the death within 24 hours of its occurrence.

#### 7. STARTING

#### False Start

• Renumber existing Rule 141(1) to 141(1)(a) • Add new Rule 141(1)(b)

#### 141.(1)

- (a) In mobile start races the starter may declare a false start if at or before the starting point a horse causes interference to another runner, falls, breaks gear or scores up in front of the gate or in an incorrect barrier position.
- (b) If in the opinion of the Stewards a horse has been denied a fair start then subject to Rule 15(2) the Stewards may declare such horse a non-starter.

#### 9. DRIVERS

#### Horse breaking gait New Rule 155A

155A. (1) Notwithstanding the provisions of Rules 154 and 155 any horse which has broken gait free of interference, and remains in the incorrect gait when its nose reaches the finish line, and is covered by any other horse or horses in the correct gait it shall be placed behind such horse or horses.

(2) For the purposes of sub-rule (1) "covered" means when a horse has its nose in line with any part of the breaking horse's body when the nose of the breaking horse reaches the finishing line.

Offences - relating to matters at the start and during the race

- Renumber existing Rule 163(1)(b) to Rule 163(1)(b)(i)
- Add new Rule 163(1)(b)(ii)
- 163.(1) A driver shall not:-
  - (b) subject to rule 164
    - (i) make another horse cover more around than necessary
    - (ii) impede the forward progress of another horse:

#### Offences - relating to sulkies

#### Amend 170(3)

• Renumber existing Rule 170(3) to 170(4)

170.(3) A driver or person in charge of or responsible for affixing a sulky to a horse shall ensure that the sulky is affixed in a manner which prevents the hind legs of the horse from contacting any part of the sulky or the driver's feet.

(4) A driver who fails to comply with any provision of this rule is guilty of an offence.

#### Offences – relating to mobile phone use

- New sub-heading
- New rule 172

172.(1) A person driving or riding a horse in a race shall not use or have in his possession any mobile communication device.

- (2) A person driving, riding or handling a horse shall not use any mobile communication device.
- (3) A person who fails to comply with sub-rule (1) or (2) is guilty of an offence.

#### Offences - relating to betting • Amend Rule 173(4)

173.(4) A licensed person shall not authorise, enable, permit or allow another person to place a bet on a betting account of the licensed person.

#### 12. PROHIBITED SUBSTANCES

#### **Anabolic Steroids**

#### Amend preamble to Rule 190AA(4)

190AA. (4) When a sample taken at any time from a horse has detected in it an anabolic androgenic steroid the horse is not permitted to start in any race or be used for the purposes of breeding:

#### **Bisphosphonates**

- Renumber existing Rule 190AB(6) to 190AB(8)
- New Rule 190AB(6)
- New Rule 190AB(7)

190AB.(6) For the purposes of this Rule and Rule 190A an unregistered bisphosphonate means a bisphosphonate that is not registered for veterinary use in Australia.

- (7) For the purposes of this Rule a registered bisphosphonate means a bisphosphonate that is registered for veterinary use in Australia.
- (8) When a sample taken from a horse has detected in it a bisphosphonate in breach of sub-rules (1), (4) or (5) the trainer and any other person who is in charge of such horse at the relevant time shall be guilty of an offence.

#### Unregistered Substances Amend Rule 194

194. A person who:

- (a) Procures or attempts to procure:
- (b) Has in his possession or on his premises or under his control:
- (c) Administers or attempts to administer; any substance or preparation that has not been registered. labelled. prescribed or obtained in compliance with relevant State and Commonwealth legislation is guilty of an offence.

#### Amend Rule 194A

194A. A person who:

- (a) Sells or attempts to sell;
- (b) Supplies or attempts to supply:
- (c) Distributes or attempts to distribute; any substance or preparation that has not been registered, labelled, prescribed or obtained in compliance with relevant State and Commonwealth legislation is guilty of an offence.

#### 13. PRIZEMONIES

#### Objections • Amend Rule 201(2) • Add new Rule 201(3), (4)

201.(2) If prizemoney is paid out before the determination of an objection lodged in accordance with Rule 177 and that objection is upheld then such prizemoney shall be refunded or returned immediately by the connections to the Club which conducted the race or to the Controlling Body.

- (3) A person who fails to comply with sub-rule(2) is guilty of an offence.
- (4) For the purposes of this Rule prizemoney includes float rebates, time incentives conditional and unconditional bonuses (including cash and the retail value of vouchers, credit, goods and/or services).

#### **14. GENERAL OFFENCES**

#### Alcohol and related matters • Amend preamble to Rule 251

251. The following substances and/or their metabolites, artifacts, and isomers are declared as banned substances in drivers when present in a sample (unless otherwise stated) at a concentration above the applicable cut-off level:-

#### Amend preamble to Rule 251A

251A. The following substances and/or their metabolites, artifacts, and isomers are declared as banned substances when present in a sample (unless otherwise stated) at a concentration above the applicable cut-off level in persons carrying on or purporting to carry on an activity regulated by licence at any time or carrying on official duties at a race meeting:-

#### New Rule 252E

252E. (1) A certificate from a person or drug testing laboratory approved by the Controlling Body which certifies the presence of a banned substance in or on a person at, or approximately at a particular time or in blood, urine, saliva or other matter or sample or specimen tested is prima-facie evidence of the presence of a banned substance.

- (2) If another person or drug testing laboratory approved by the Controlling Body analyses a portion of the sample or specimen referred to in sub rule (1) and certifies the presence of a banned substance in the sample or specimen that certification together with the certification referred to in sub rule (1) is conclusive evidence of the presence of a prohibited substance.
- (3) A certificate furnished under this rule which relates to blood, urine, saliva, or other matter or sample or specimen taken from a person shall be prima facie evidence if sub rule (1) only applies, and conclusive evidence if both sub rules (1) and (2) apply, that the sample taken from the person was not free of a banned substance.
- (4) A certificate furnished under this rule which relates to blood, urine, saliva, or other matter or sample or specimen taken from a person shall be prima facie evidence if sub rule (1) only applies, and conclusive evidence if both sub rules (1) and (2) apply, that the banned substance was present in or on the person at the time the blood, urine, saliva or sample or specimen was taken from the person.
- (5) Sub rules (1) and (2) do not preclude the presence of a banned substance in or on a person, or in blood, urine, saliva, or other matter or sample or specimen being established in other ways.
- (6) Sub rule (3) does not preclude the fact that a person provided a sample not free of a banned substance being established in other ways.
- (7) Notwithstanding the provisions of this rule, certificates do not possess evidentiary value nor establish an offence, where it is proved that the certification procedure or any act or omission forming part of or relevant to the process resulting in the issue of a certificate, was materially flawed.

#### 17. EQUIPMENT AND COLOURS Offences

#### • Amend Rule 273(3)

273. (3) A person shall not without the permission of the Stewards start a horse in a race unless the horse is fitted with a false belly band or retaining straps and throat lash and a breast plate.

#### 18. STUDS, SIRES and STUD BOOK

#### Australian Trotting Stud Book

280A. (1) The Keeper of the Stud Book shall publish annually the Australian Trotting Stud Book.

- (2) The Keeper of the Stud Book shall determine the style, form, and layout of the Australian Trotting Stud Book.
- (3) The Australian Trotting Stud Book shall contain the following Tables:

#### Table 1 – Sires Part A – General List

This part shall comprise Standardbred sires that have sired progeny or winners subsequent to the publication of the previous Stud Book.

The entry therein shall include a distinctive number, best racing or time trial performance, colour, year of foaling and pedigree to second generation and the breeder's name and the State of domicile.

The entry shall also include a list of the names of mares that have produced to the sire concerned together with an annual updated list of winners and their best performances.

Qualifying Trial times shall not be recognized.

#### Part B – Tabulated Pedigrees of Stallions

This section shall include all those stallions at Stud from Australia, New Zealand, North America and Europe.

#### Table 2 – Dams Part A – General List

All Standardbred mares producing a foal to a Standardbred sire or having a previously notified foal named or having produced with new or reduced time performance or increased stakemoney subsequent to the publication of the previous Stud Book shall be automatically entered in the next following Stud Book.

The mare's entry will parallel that of a sire's entry and the breeder's name of such of her foals will also be recorded.

Qualifying Trial times shall not be recognised.

#### Part B - Tabulated Pedigrees of Dams

This section shall include all those dams bred published in Part A of this Table.

#### Table 3 – Index to Registrations

All horses whose names have been issued and/ or approved by the Registrar since the publication of the previous Stud Book shall be entered in the next published Stud Book in the Table called Index to Registrations. The entry shall include the allotted name, colour/sex, year of foaling and the breeding thereof. All such approved names shall also be entered against the dam's record of foalings.

- (4) HRA may at its discretion add additional Tables or such information as it considers necessary.
- (5) Winning performances in a race and against time endorsed by HRA shall be the only time performances recorded in the Stud Book.
- (6) Times for races less than a mile shall not be recorded.
- (7) In the event of non-compliance with Rules 93, 94, 94A, 95, 95A, 95AB or 96 HRA may direct any sire, dam or their progeny be ineligible for either naming or entry in the Stud Book, or set down conditions or require undertakings before a specific horse is named or before a sire, dam or their progeny are entered in the Stud Book.


