

# MEDIA ACCREDITATION RULES AND REGULATIONS

I ..... (Full Name) of ..... (Address)  
("You, Your") being a member of/employed by\* ..... (Company/Organisation) and  
having successfully undertaken induction for any and all Tasracing Pty Ltd ("Tasracing") owned and/or operated *venues* for  
which I may attend hereby agree to adhere to and be bound by the Tasracing Media Accreditation Rules and Regulations ("Rules  
and Regulations") set forth below.

For the purposes of the Tasracing Media Accreditation Rules and Regulations:

**"Accreditation"** means the accreditation obtained to you upon being inducted and having complied with any requirements of  
Tasracing, including your right to attend Tasracing events as an authorised media member;

**"Accreditation Pass"** means the pass containing your photograph provided to you upon being achieving Accreditation;

**"Event"** means any event conducted by Tasracing at which You are present, including race meetings and social *events* or  
functions;

**"Photography"** means and includes any visual or audio information captured on a camera, video camera, mobile phone, drone  
camera or any other device that produces and stores visual and audio information;

**"Race Club"** means, as the context requires, the racing clubs registered under the *Racing Regulation Act 2004* from time to time.

## 1 General rules and conditions

- 1.1 Accreditation is non-transferable.
- 1.2 You must ensure that your Accreditation Pass is displayed prominently at all times whilst attending any Event.
- 1.3 You are responsible for complying with the Workplace, Health & Safety rules of *venues*, as well as the Conditions of Entry to each *venue* (a copy of which can be obtained from [www.tasracing.com.au](http://www.tasracing.com.au)).
- 1.4 You must behave in a professional manner at all times and not endanger yourself or others by engaging in reckless or prohibited behaviour.
- 1.5 Photography and any form of filming are prohibited at all times on the course of any *venue* unless otherwise authorised by a Tasracing staff member as provided for in clause 7 below.
- 1.6 You must observe pre-booked workstations and telephone lines in the Press Room.
- 1.7 Subject to the Tasracing Media Accreditation Rules and Regulations You must adhere to the Australian Press Council's statements of principles (<http://www.presscouncil.org.au/statements-of-principles/>) at all times.
- 1.8 You must obey all reasonable directions given to you by Tasracing staff, race club officials, Stewards and security staff.
- 1.9 You must not act in a way that may damage the reputation of Tasracing or the Race Clubs nor use, publish or exploit any Photography in such a manner.
- 1.10 You must not make any alteration or addition to any Photography that changes the true depiction of the Photography captured, or permit any such alteration or addition to be made by any third party without the express permission of Tasracing
- 1.11 You must take out and maintain public liability insurance in the amount of \$20 million dollars and are required to provide evidence of currency of such insurance prior being inducted and at any time whilst accredited at the request of Tasracing.
- 1.12 You warrant that you have successfully undertaken the Tasracing induction for all *venues* you will attend in your capacity as a media member.

## 2 Betting areas

- 2.1 Photography in the betting ring is limited to general atmosphere shooting only.
- 2.2 You must not film or photograph individuals transacting wagers unless their explicit permission is first obtained.

## 3 Photographers and camera operators

- 3.1 You must be respectful of Tasracing and Race Club members in Reserved Enclosures at all times and seek permission to take photographs.
- 3.2 You must be considerate of all racegoers when gaining the best photographic position.
- 3.3 You must not obstruct the view of any contracted course photographer or cameraman.
- 3.4 Unless approved by a Tasracing or a Race Club, You must not attempt to sell photographs in any form to the connections (owners, trainers, jockeys, strappers etc.) of any horse from Tasmanian race meetings and must not advertise to supply photos to connections.
- 3.5 You must direct any enquiries from connections to the contracted course photographer at the particular race course.

## 4 Copyright

- 4.1 Copyright in any Photography captured by you whilst attending an Event belongs to Tasracing.
- 4.2 You must make available to Tasracing, and/or the Race Clubs (upon request by Tasracing), free of all charges all Photography captured by you.
- 4.3 You must delete and destroy any Photography captured at an Event if so requested to do so by Tasracing.

## **5. Thoroughbred and harness stabling and mounting yard areas**

- 5.1 The stabling and mounting yard areas are designed specifically for trainers, horses, jockeys, and connections, prior to and after races, and course officials. Whilst in these areas You must act with extra care and diligence and otherwise in accordance with these Rules and Regulations.
- 5.2 Tasracing may limit or restrict access to these areas at any time and at their sole discretion.

## **6. Greyhound kennels and parading area**

- 6.1 The Greyhound kennels, parade and presentation areas are areas designed specifically for trainers, greyhounds, and connections, prior to and after races, and course officials. Whilst in these areas You must act with extra care and diligence and otherwise in accordance with these Rules and Regulations.
- 6.2 Tasracing may limit or restrict access to these areas at any time and at their sole discretion.

## **7. Track photography**

- 7.1 You are not to take Photography using cameras outside of the stabling and mounting yard areas (e.g. on the inside track or starting barrier) without requesting permission to do so prior to the event.
- 7.2 A request pursuant to clause 7.1 is to be made to Tasracing ([marketing@tasracing.com.au](mailto:marketing@tasracing.com.au)) and is to outline the activities which you intend to undertake.
- 7.3 Tasracing may refer a request pursuant to clause 7.1 to the Stewards (or may elect not to at their absolute discretion) for approval. You will be advised of the outcome of your request

## **8. Dress code**

- 8.1 You must adhere to the dress codes for all Events set out by Tasracing or a Race Club.

## **9. Breach of media accreditation**

- 9.1 Failure to abide by these Rules and Regulations may result in termination of Your Accreditation.

## **10. Indemnity**

- 10.1 You indemnify and will keep indemnified each of Tasracing, the Race Clubs and their respective officers, employees, agents and contractors against any and all claims, damage and/or loss arising from a breach or breaches of these Rules and Regulations or any other legal obligation by You.

## **11. No Relationship or Exclusivity**

- 11.1 Nothing in these Rules or Regulations confers on You any right to be the sole or exclusive provider of Photography services to Tasracing.
- 11.2 Nothing in these Rules and Regulations constitutes You as an agent, employee, director or partner of Tasracing.

## **12. Privacy**

- 12.1 Tasracing may gather and process information provided by You in relation to providing Accreditation. Any information collected by Tasracing will be handled in accordance with its Privacy Policy accessible at [www.tasracingcorporate.com.au](http://www.tasracingcorporate.com.au).

## **13. Termination of media accreditation**

- 13.1 Tasracing may terminate Your Accreditation at any time at its sole discretion.
- 13.2 Tasracing may, at its sole discretion, deny access to the course or parts thereof without reason.
- 13.3 You acknowledge and agree that Tasracing will have no liability for any costs, losses or damages of any kind arising as a consequence of termination of your Accreditation under any circumstances.
