



TASRACING COVID SAFE STANDARD OPERATING PROCEDURES

HARNESS TRIALS - STATEWIDE





EXECUTIVE SUMMARY

Harness Trials are critical to the safety and welfare of the horse as well as the efficient operation of normal race meetings.

Harness Trials are to be conducted at a racetrack with no more than 10 people in any one operational location of the racecourse facilities.

Harness Trials definition:

- Trials in the harness code refer to the training and education of standardbreds for the purpose of fitness, remedial work, injury management, education and qualifying to race.
- They differ from racing in that there are significantly less participants and minimal officials required for them to be run.
- This document outlines Tasracing's Standard Operating Procedures for Harness Trials during COVID-19 (CSOP's).
- Tasracing's harness trial operations will be managed strictly in-line with these CSOPs and will also adhere to WorkSafe Tasmania's Guidelines for COVID Safe Workplace operations.
- Tasracing has allocated a new supervisory role in the form of 'Track Marshall'. Track Marshalls will oversee and enforce these CSOPs. Tasracing's Track Marshalls will be assisted by Office of Racing Integrity Stewards who have existing powers to enforce all Tasracing operational procedures.



EXECUTIVE SUMMARY (cont')

WorkSafe Tasmania's COVID Safe minimum standards required to be met at a workplace are as follows:

- manage the risks of a person contracting or spreading COVID-19 in the workplace
- implement and maintain a cleaning schedule across the workplace
- have good hygiene procedures and practices (such as washing and/or sanitising of hands)
- ensure workers who have been instructed to quarantine or self-isolate don't come to the workplace
- make sure physical distancing requirements are met by workers, contractors and others entering, leaving or moving around the workplace.
- provide information, training and supervision on how the risks of COVID-19 are to be managed and ensure all processes and procedures are applied by the workers.
- provide information and instruction to other people who attend the workplace about how they are to comply with your processes and procedures, and make sure they apply them.

Trial procedures to be reviewed on an ongoing basis with any changes to be notified to industry.



TRIAL DAY PROTOCOLS

BEFORE LEAVING HOME

If you identify as any of the below factors, it is recommended you stay home and not attend any meeting.

- Are suffering coronavirus symptoms or are otherwise unwell.
- Are subject to self-isolation requirements imposed by the Government
- Have been in close contact with a person suspected or confirmed to have coronavirus.

People aged 70 years and over, people aged 65 years and over with chronic medical conditions, people with compromised immune systems, and Aboriginal and Torres Strait Islander people over the age of 50, are at greater risk of more serious illness if they are infected with COVID-19. Chronic medical conditions include diabetes, lung disease, heart disease, cancer and kidney failure. There is currently no cure or vaccine for COVID-19 coronavirus, or immunity in the community, so you need to protect yourself. so you must exercise a high degree of caution when deciding to attend race meetings and trials.

Tasracing strongly recommends that people most at risk continue to stay at home, avoid contact with others and carefully consider whether attending race meetings and trial sessions (including accessing licensed kennels) will compromise their health. Should you attend race meetings and trial sessions, Tasracing reminds you to practice good hygiene and physical distancing measures to ensure your health and wellbeing.

Any race day staff or participants will be refused entry at the venue if they display any of the following symptoms:

- *Fever above 38 degrees*
- *Cough*
- *Any flu or cold-like symptoms.*

VENUE RESTRICTIONS AND HYGIENE

- No food or drink will be available for purchase or distribution at venues.
- Tasracing will permanently open doors where possible to allow access without touching surfaces.
- Tasracing will provide suitable gloves for participants to wear if they wish.
- Hand sanitiser will be supplied at the entry to the venue, toilets, stables and throughout the remainder of the venue.
- Attendees should wash/sanitise their hands thoroughly throughout the trials where possible.



TRIAL DAY PROTOCOLS (cont')

SOCIAL DISTANCING

- All approved race day personnel and participants are required to comply with the strict social distancing requirements while attending race meetings and trial sessions.
- Minimum 1.5 metres between any two personnel at all times where possible.

OBEY STEWARDS AND COVID-19 TRACK MARSHALLS

- Participants and trial day personnel will be advised that Stewards and Track Marshalls will be observing all personnel at all times to ensure compliance with protocols.
- Stewards or Track Marshall's will instruct any person breaching these protocols to leave the venue immediately.
- Compliance with protocols will be enforced as a direction of the Stewards, non-compliance will be dealt with under the provisions of AHRR 238.

DUTIES OF TRACK MARSHALLS

- Tasracing will provide COVID-19 Track Marshalls at every trial meeting.
- Track Marshalls will be responsible for ensuring all documented protocols are adhered to by all staff and participants.
- Track Marshalls will be authorised to demand identification information and will report any breach to race day stewards.

VENUE SIGNAGE AND SOCIAL DISTANCE MARKINGS

- Tasracing will display clear instructions and reminders on these protocols at all racing and training venues.
- Floor and ground markings will be installed where possible to ensure all personnel adhere to social distancing protocols.



TRIAL DAY PROTOCOLS (cont')

VENUE ENTRY PROTOCOLS

- The venue will have only one designated entry/exit point.
- Photo ID must be presented by ALL persons seeking entrance.
- Tasracing encourages all licensed participants to play an important role in helping stop the spread of COVID-19 by downloading the COVIDSafe app. Downloading the app is something you can do to protect yourself, your family and the industry. The app helps expedite contact tracing and serves to benefit the racing industry in the event the app user tests positive for COVID-19. If you do not wish to download the app or do not have a smartphone to download the app, Tasracing recommends that you maintain a travel log to perform a similar function.
- The minimum requirement for travel detail to be kept by a participant attending a trial meeting (who does not have the COVIDSafe app) will be as follows:
 - Day and Date
 - Name of persons making the journey
 - Address from which departed
 - Location of any stops during the journey (road, town, business)
- Security staff will check every attendee off the official approved attendee list for trial day.
- Fever testing will be conducted at the venue entry. Any person who returns a temperature reading of more than 38 degrees, and/or submits answers which indicate possible COVID-19 exposure will be refused entry to the racecourse.
- A hygiene station will be located at the entrance and at other locations throughout the venue.

TRANSPORT CONTROLS

- On commencement of travel, personnel are to avoid un-necessary toilet, food, petrol or other stops.
- All travel must be completed in the one day (no overnight stops).



TRIAL DAY PROTOCOLS (cont')

ENTRY TO STABLING AREA

- Stall allocation on trial day will provide minimum one stall as spacing between each stable group to assist with social distancing.

STABLEHANDS

- Trainers are required to nominate the stablehand who will assist them on trial day.
- One stablehand permitted per (up to) five horses. Up to a maximum of six total stablehands.
- Any exception to the above must be approved by Tasracing and ORI prior to any meeting.

STARTING

- Only mobile starts will be permitted to reduce pre-trial interaction.
- One mobile starting barrier driver per zone will be allocated (total two drivers).

OTHER

- Drivers only permitted to wear one set of silks per meeting.
- Drivers to wear gloves when handling horses at all times.
- Hand sanitiser will be available in the stables to use

FIELDS

- Fields sizes will be limited to five (5)
- Number of trials will be determined after nominations have closed
- Trial fields will be designed around Trainers so that on course numbers are minimised



TRIAL DAY PROTOCOLS (cont')

TRIAL DAY

- Approved Industry personnel will only be able to access the venue 30 minutes prior to their first trial.
- Stalls will be allocated to ensure physical distancing.
- Large stables will be allocated a set area within stable complex
- Saddlecloths are to be collected and returned to stable office and to be sanitised after each race
- Trainers must have horses cross tied to stalls with reins on the drivers seat or dust sheet ready for driver to collect for trial.
- Those persons only engaged as a Driver must only enter the stabling area when collecting their drive. Gloves to be worn at all times
- Trials will be charged at \$10 p/trial. Tasracing will invoice trainers. No cash is to be exchanged on track.

VENUE ACCESS – APPROVED PERSONNEL

- Trainers to notify of attending stablehands by 4pm close of nominations day.
- Approved personnel list sent to Security 5pm close of nominations day.
- Only approved personnel listed will be allowed entry.
- Notifications to be advised to racing@tasracing.com.au

TRIAL DAY PROTOCOLS (cont')

TRIAL DETAILS

- Mobile Start trials only to be held
- Distances to be run:
 - Hobart 1609m and 2090m
 - Launceston 1680m and 2200m
- Qualifying and Open trials to be scheduled.
- Nominations to be submitted via harness.org
- Field sizes limited to five (5)
- Stall Directory to be allocated on trial days
- 30 minutes scheduled between trials
- Fields will be drawn considering trainer's location / total nominations to reduce on course population.
- Trainers / Stablehands / Drivers to leave venue within 20 minutes of final engagement
