Nomination Dates	Hobart Cup nominations close on 12.00pm on 7 February 2022 (1 st close date) Launceston Cup nominations close on 12.00pm on 16 February 2022 (2 nd close date)
Eligibility	Entry is open to horse trainers from Tasmania and Victoria, who are at least eighteen (18) years of age and are the registered trainer for one and the same horse that is nominated to race in both the Ladbrokes Hobart Cup at Ladbrokes Park Elwick Racecourse on 13 February 2022 (Hobart Cup) and the Ladbrokes Launceston Cup at Ladbrokes Racing Centre Mowbray on 23 February 2022 (Launceston Cup). The horse in both races must be owned and trained by the same connections (same owner/s and trainer). To be eligible, trainers must have nominated horses before the nomination closing dates.
Method of Entry	Entry of a horse owned and trained by the same connections into both the Hobart Cup and Launceston Cup automatically results in the trainer of the horse entering into the Competition.
Prize Money Details	Total prize money is one hundred thousand dollars (\$100,000.00), which will be divided into the following payments: <ul style="list-style-type: none">• Fifty thousand dollars (\$50,000.00) for the owner/s of the horse that wins both the Hobart Cup and Launceston Cup; and

	<ul style="list-style-type: none">• fifty thousand dollars (\$50,000.00) will be paid to the trainer of the horse that wins both the Hobart Cup and Launceston Cup. <p>The registered horse trainer of the same horse that wins both the Hobart Cup and Launceston Cup is the 'Winner' and is entitled to \$50,000.00. The Winner is responsible for paying and distributing the \$50,000.00 in prize money owing to the horse owners in accordance with these Terms and Conditions and warrants that it has the authority to do so.</p> <p>The Winner will be notified in writing via the contact details registered with Racing Australia for the horse trainer. The Winner will also be published within forty-eight (48) hours after the Launceston Cup on tasracingcorporate.com.au, and the name will remain published for at least twenty-eight (28) days. The prize money will be paid to Winner on the condition that the Terms and Conditions of the Competition are satisfied.</p>

1. This Competition is run by Tasracing Pty Ltd (ABN 62 269 303 946) of Ladbrokes Park Elwick, 6 Goodwood Road, Glenorchy Tasmania 7010 (**Promoter**).
2. This Competition is governed by these Terms and Conditions.
3. All eligible entries into this Competition constitutes the horse trainer's acceptance of these Terms and Conditions.
4. All instructions on how to enter this Competition, and the Competition Schedule, form part of these Terms and Conditions.
5. These Terms and Conditions comply with the trade promotion lottery conditions set by the *Gambling Regulation Act 2003* (Vic) and the *Gambling Regulations 2015* (Vic).
6. By entering this Competition, all eligible horse trainers agree and acknowledge that any personal information provided will be taken and managed for the purposes of the Competition and in accordance with the Promoter's Privacy Policy, located at <https://tasracingcorporate.com.au/about/governance/privacy-policy/#:~:text=We%20will%20not%20collect%20your,our%20functions%20and%2For%20activities>. Information provided to the Promoter may also be passed on to third parties.
7. All horse trainers entering this Competition warrant that they are the registered trainer of the same horse that they have entered into both the Hobart Cup and Launceston Cup, and that they have authority from the horse owners to receive and disburse to them any Prize Money from this Competition which they are entitled to. The Winner of this Competition guarantees to pay \$50,000.00 of the Prize Money to the horse owners in correspondence with each owner's respective shareholding in the

horse, and in accordance with the terms of the agreement between the trainer and the horse owners.

8. There is no fee to enter this Competition aside from the normal entry costs associated with the Hobart Cup and Launceston Cup. This Competition is run as a trade promotion and any horse trainer of a horse that wins both the Hobart Cup and Launceston Cup is the Winner, subject to the Terms and Conditions of this Competition.
9. The Promoter accepts no responsibility for any late, lost or misdirected entries including delays due to technical disruptions, network congestion or for any other reason. Any entries received after the nomination closing dates have ended for either the Hobart Cup or Launceston Cup will not be accepted. The time that an entry is received is the time the entry is received by the Promoter and is not the time of transmission by the sender of the entry.
10. Subject to the other terms and conditions regarding this Competition, Prize Money under this Competition is only paid to the Winner within twenty-eight (28) days of the latter of:
 - (a) the race results of the Hobart Cup and Launceston Cup being finalised by the racing stewards; or
 - (b) the testing of the winning horse's blood and urine samples producing a negative result for prohibited substances.
11. The Prize Money cannot be substituted for another prize.
12. If the winning horse's blood or urine samples return a positive result for prohibited substances for the Hobart Cup and/or Launceston Cup, the horse will be disqualified, and any of the horse's owners and trainer otherwise entitled to the Prize Money will be removed from the Competition and not entitled to the Prize Money. If this means that there is a new Winner (there is a horse that placed second in both races with the same owner/s and trainer/s which is now considered to have placed first), the Prize Money will be paid to that Winner in accordance with these Terms and Conditions.
13. If the winning horse or Competition Winner is disqualified from the Hobart Cup or Launceston Cup by racing officials other than by virtue of a positive result for prohibited substances (see clause 12), the Winner or horse owners otherwise entitled to Prize Money will be removed from the Competition and will be required to repay any Prize Money (if relevant). If this means that there is a new Winner (there is a horse that placed second in both the Hobart Cup and Launceston Cup with the same owner/s and trainer/s which is now considered to have placed first), the Prize Money will be paid to that Winner in accordance with these Terms and Conditions.
14. The Promoter will pay the Prize Money to the Winner subject to the Terms and Conditions of this Competition, and in accordance with the horse trainer financial details registered with Racing Australia.
15. If a 'dead heat' event occurs in the Hobart Cup and/or Launceston Cup, which is when there is a tie between two horses for first place in a race, and a photo finish cannot determine a single winning horse, there can still be a Winner of the Competition. A

horse will be considered to have won both the Hobart Cup and Launceston Cup even if it is involved in one or two dead heats with different horses.

16. In the event that a 'dead heat' occurs in both the Hobart Cup and Launceston Cup, and the same two horses are involved in both dead heats, they will both be considered winners of the races. In this instance, the Prize Money will be divided equally between the horse trainer of both horses (\$25,000.00 each), and they guarantee the distribution of the \$25,000.00 that the owners of each horse are entitled to, to them, in accordance with their respective shareholding and agreement with the owners.
17. The Winner authorises the Promoter, in advertising the Winner of the Competition, to advertise their name in any publication of the Promoter. Winners also grant the Promoter and third parties authorised by it permission to use images or recordings of them, or other images or likeness of them in any media throughout the world and for any purpose (including promotional purposes), without identification, nor further request for consent or compensation of any kind.
18. The Promoter may terminate the participation of any horse trainer in this Competition immediately without notice in its sole discretion in certain situations, including, but not limited to, where the horse trainer:
 - (a) fails to comply with these Terms and Conditions;
 - (b) provides misleading information or makes a misrepresentation to the Promoter;
 - (c) engages in unlawful conduct (including conduct contrary to any industry rules);
or
 - (d) abuses any of the Promoter's employees or officers
19. If the Winner engages in any of the conduct outlined in clause 18, the Promoter may request the return of the Prize Money paid to the Winner (if relevant), and the Winner must return the Prize Money within seven (7) days of being requested to do so.
20. Any decisions of the Promoter in respect to the Competition are at the Promoter's sole discretion and are final.
21. Except for any liability that cannot be excluded by law, the Promoter (including its officers and employees) is not responsible for and excludes all liability (including negligence), for any personal injury, or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Competition, including but not limited to, where arising out of:
 - (a) any horse nomination entry that is late, lost, altered, damaged or misdirected (whether or not after receipt by the Promoter) due to any reason beyond the Promoter's reasonable control;
 - (b) if the Prize Money is cancelled, delayed, suspended or postponed for any reason by the third-party provider or beyond the Promoter's reasonable control, including if this is due to the cancellation or rescheduling of the Hobart Cup or Launceston Cup;
 - (c) Prize Money and use of Prize Money once it is paid to the Winner of the Competition;

- (d) if any tax liability is incurred by the Winner or other party as a result of receiving the Prize Money or the Competition; or
 - (e) a breach of these Terms and Conditions.
22. Horse trainers that have entered the Competition, including any Winner of the Competition, will indemnify the Promoter against all present and future legal liability, claims and proceedings for:
- (a) personal injury or death to any person;
 - (b) either or both loss of or damage to property; and
 - (c) financial loss of a trainer, Winner or a third party,
- as a direct or indirect result of the trainer or Winner entering a horse into this Competition and handling and/or distributing any Prize Money on the authority of the horse owners, to the extent that the injury, death, damage or loss is not caused or contributed to by a deliberate and/or wrongful (including negligent) act or omission of the Promoter.
23. If the Hobart Cup or Launceston Cup is cancelled and not rescheduled, this Competition will be cancelled and horse trainers and owners will not be entitled to any Prize Money.
24. The Promoter may, in its sole discretion, amend these Terms and Conditions with any changes that it sees fit, and will give notice of any change to the Terms and Conditions via the Promoter's website (tasracingcorporate.com.au) or via direct communication to trainers.
25. The Promoter reserves the right in its sole discretion to verify the validity of entries into the Competition.
26. The Competition and these Terms and Conditions are governed by the laws of Tasmania.
