## CATEGORY | ELIGIBILITY

- A TASMANIAN SIRE**  
A foal conceived in Tasmania and sired by a stallion which stood in Tasmania during the stud season in which the foal was conceived.
- B INTERSTATE SIRE** [BREEDBACK\*]  
The dam at the time of foaling must be Tasmanian-owned, based on Australian Stud Book breeder location.  
\*When a yearling is not eligible for Category A and its dam was served by a Stallion who stood in Tasmania during the 2019 breeding season.
- C TASMANIAN REARED**  
The foal and dam must have resided in Tasmania for at least six (6) continuous months between when the foal was born and the foal's first birthday as listed by the Australian Stud Book.
- NOTE: Nominators will be required to supply sufficient documentation that verifies the nomination meets the category C criteria at time of nomination.
