

## **GREYHOUND RETIREMENT PREPARATION SCHEME (GRPS) APPLICATION INSTRUCTIONS**

### **Who can apply for reimbursement under the Scheme?**

The *Applicant* must be the *Licensed Person* responsible for the care of an *Eligible Greyhound* to apply to Tasracing for reimbursement under the Scheme.

### **What is an Eligible Greyhound?**

An *Eligible Greyhound* is a canine of the greyhound breed which:

- A. Was registered pursuant to the Rules of a Controlling Body; and
- B. The Greyhound must be domiciled in Tasmania at the time of retirement; AND
- C. Has been bred in Tasmania; OR
- D. Has had at least one race start in Tasmania; OR
- E. Has been domiciled in Tasmania with a licensed person for a minimum of six consecutive months at the time of lodging wind-down notification.

### **What supporting information do I need to provide with this Application Form?**

An *Applicant* who applies to Tasracing for reimbursement under the Scheme will need to provide the following documentation (which clearly identifies the *Eligible Greyhound*) in support of their application:

- A. Desexing Certificate; and
- B. Vaccination Certificate (if applicable); and
- C. Clinical notes from the veterinarian detailing all treatment and procedures performed; and
- D. Itemised tax invoice (in the name of the *Applicant*) and receipt of payment for the *Specified Expenses* incurred.

## What are the Specified Expenses?

*Specified Expenses* include expenses for desexing, dental prophylaxis and treatment (including extractions), vaccination and pre-anaesthesia blood tests (See below for maximum reimbursement amount per procedure)
