

Quick Reference Guide: Greyhound Retirement Preparation Scheme (GRPS)

Important facts:

- To be eligible for a rebate, desexing and any required dental treatment and vaccination (as deemed by the attending vet) must be completed before lodging a reimbursement application, unless you meet the condition outlined in section 4.1 of the GRPS Policy.
- The licensed person must:
 - Submit a notification of retirement (wind-down notification) with the Office of Racing integrity a minimum of 14 days prior to desexing/dental treatment.
 - o Book in the greyhound for treatment with their preferred veterinary practice and pay for the costs of treatment.
 - O Complete the GRPS application form to apply for a rebate of eligible costs, capped as per the table below.
 - o Include the following supporting documents when lodging a GRPS Application (all documents must include official identification details of the greyhound: ear brand, race name, microchip number):
 - a) Copy of the paid itemised veterinary account (if dental treatment is required, this must be completed and paid for prior to lodging your claim)
 - b) Dental Certificate
 - c) Desexing Certificate
 - **d)** Vaccination Certificate (must be administered at the time of desexing/dental treatment to be eligible to claim for reimbursement of cost up to \$100)
- Upon receipt of a GRPS application and supporting documentation, Tasracing will assess the application and, if successful, pay the applicable GRPS rebate within 14 days.
- It is the applicant's responsibility to ensure Tasracing has their current banking details.
